

# Terms of Service

## 1. Introduction

### 1.1. Purpose of the Terms

Welcome to YongSanCats! These Terms of Service ("Terms") govern your use of our platform, including our website, mobile applications, and other features (collectively, the "Platform"). ## 2. Definitions

**Account:** A unique account created by a user to access and utilize our services.

**Beneficiary:** The individual, group, or entity intended to benefit from donations or fundraisers.

**Donor:** Any individual or entity contributing funds to a fundraiser on the Platform.

**NFT Certificate:** A non-fungible token issued as a certificate of appreciation for donations.

**Fundraiser:** A campaign created on the Platform to raise funds for a specific purpose.

**Services:** The features, tools, and functionalities offered by the Platform.

**User:** Any individual or entity accessing or using the Platform, including donors, fundraisers, and beneficiaries.

**User Content:** Any content uploaded or submitted by users on the Platform, such as text, images, or videos.

## 3. The Services We Provide

### 3.1. Description of Services

YongSanCats provides a platform for creating fundraisers to support the rescue and care of animals. Donors can contribute funds, and in appreciation, we provide NFT certificates for their support.

### 3.2. Our Role and Limitations

We facilitate connections between donors and fundraisers but are not a bank, financial advisor, or charity. We do not solicit donations or guarantee the success of any fundraiser. It is your responsibility to evaluate fundraisers before contributing.

## **4. Account Creation and Eligibility Requirements**

### **4.1. Registration**

To access certain services, you must create an account with accurate and complete information. Keep your information up to date to ensure uninterrupted service.

### **4.2. Age Restrictions**

You must be at least 18 years old to use our Platform. Minors under the age of 18 may use the Platform only with parental or guardian consent.

## **5. Donations and NFT Certificates**

### **5.1. Donations**

Donations are voluntary and non-refundable. By making a donation, you agree to the terms set by the fundraiser.

### **5.2. NFT Certificates**

NFT certificates are issued as tokens of appreciation and have no monetary or speculative value. The transfer and storage of NFTs are subject to blockchain network availability.

## **6. User Responsibilities and Obligations**

### **6.1. Fundraiser Organizers**

Organizers must provide accurate information about their campaigns and ensure funds are used for their stated purpose. Misuse of funds may result in suspension or legal action.

### **6.2. Donors**

Donors must provide valid payment information and understand how their contributions will be used. We are not responsible for verifying the accuracy of fundraiser claims.

## **7. Fees**

### **7.1. Platform Fees**

We do not charge fees to create or manage fundraisers. However, transaction fees may apply to donations processed by third-party payment providers.

## **8. Prohibited Activities**

Users may not use the Platform for illegal activities, misleading fundraisers, or any purpose that violates local laws or these Terms. Violations may result in account suspension or legal action.

## **9. Dispute Resolution & Arbitration**

### **9.1. Informal Resolution**
